ARGENTINE HAMS are off the air, according to ARRL's WIAW Bulletin. The suspension came on April 29. Mail service has not been affected. WA2VUY reports (on a related topic) that LU3ZY QSL requests sent to LU2CN have often gone astray, some envelopes opened and money removed. He suggests holding off on sending any more cards down there until some different arrangements can be made.

JAIBRK and JASCDT signed 3X3JA from Guinea (QSLs to JAIHGY) with a big signal on 80 Meters. W4LZZ has also been heard from Guinea again as 3X1Z, following his trip to the States and to Dayton. Jacques says he might try for Mali TZ licensing before returning to the U.S. this summer.

Don Riebhoff, K7ZZ, of XV5AC and XU1DX and CT4AT fame, is in Washington learning another language, and expects his next assignment to be IRAQ. He spent the last couple of years in Czechoslovakia and was allowed to operate from various club stations, but never managed a license for himself.

WILLIS Island operations follow the VK9ZR Mellish now in progress; although many stations have been active from Willis recently, much pent-up demand for CW contacts should keep Banyandah's team busy.

MARTTI LAINE, OH2BH, in addition to his efforts toward Albania, is said to be possibly joining several Finnish visitors to China in September. For the present, VE7BC has reported that only the Chinese themselves are allowed to operate the BY1PK station.

BILL HATCHER, KP4KK, made 30,000 contacts from the Philippines while stationed there with the Navy. He will next go to Portugal for a two-year stay, beginning in July, and should have a call shortly thereafter. In eleven months /DU2 Bill made 5-Band DXCC and worked thirty three countries on 160 Meters.

1AØKM SMOM still in great demand, especially on the U.S. West Coast. No activity is expected until Fall. Mario, IØMGM, has taken over the QSLing chores (again) and says about a hundred cards a day are getting mailed. Hang in there if you don't have yours yet.

SMØGMG expeditions to OHØ (Nov 81) and to CT3 (Mar/Apr 82) are being QSLed by SMØDJZ, who will have another batch printed by mid-May. Patience!

THE IRISH RADIO TRANSMITTERS SOCIETY will sponsor EJØRTS from one of the ARAN ISLANDS May 21-23. These islands count for the "Islands on the Air" award. Look for them on 80-10, CW and SSB. The IRTS is at Box 462, Dublin 9, Rep. of Ireland.

ARRL's DX Advisory Committee is now talking about adding North Korea to the Countries List (along with several other hot topics). It does NOT seem that any stations are on from there now, and some activity might be necessary before the addition is made. North Korea would instantly become one of the rarest on the list when it makes it

The initial groundwork was laid by a group calling itself the "VK6 DX Chasers Club," and the work has been going on for quite some time.

HEARD ISLAND - HALF WAY!
Manahawkin, New Jersey, April 27, 1982

Dr. Dan Handelsman, N2DT, of the International DX Foundation, announced at the DX Forum in Dayton on April 24, 1982, that a three-month amateur radio expedition to Heard Island would be launched January through March 1982 if the world DX community wants to hear Heard.

This effort is being organized by VK6XI and N2DT with the sponsor-ship of the Wireless Institute of Australia, the Northern California DX Foundation and the International DX Foundation. WIA will supply four complete stations and \$7,000. NCDXF will donate \$5,000, and the IDXF will donate at least \$10,000 for a total of \$22,000 out of estimated expenses of \$30,000.

The expedition will be primarily a mountaineering effort with the crew consisting of 6 mountaineers who will bear most of the expense of the trip and 2 amateurs—one from Australia and one from the U.S.A. This should cover the demand for Heard because the mountaineers need six weeks to scale the over 3,000 meter high ice covered volcano on the island, and as there is little diversion on this desolate island, there will be nothing for the two amateurs to do for 42 days but talk to the world. There will be no list operations and selective calling will be avoided if possible. Amplifiers and beam antennas will assure control of the pile-ups. The operators will be chosen by the sponsors for their operating skill, technical (repair) ability and physical stammina. All bands 160 through 10 meters will be covered. SSB and CW will receive equal time and the General and Novice segments will be worked.

The IDXF is putting up the largest amount of cash for this effort and invites the other DX associations of the world to make their contributions or pledges directly to the WIA. The IDXF is an on-going membership organization with over 1,000 active members and sponsors many expeditions such as the 1982 Navassa effort (33,500 QSO's) and the 1981 Desecheo operation (43,000 QSO's) as well as training and equipment donations to third world nations such as 3X, 4S7, 8Q7, CR9, EL, J7, etc. Thus, the IDXF is not soliciting donations for Heard but rather is asking the DX community to show its support by responding to a membership drive. Suggested donations are \$25 for a one year sustaining membership or \$500 for a life membership, but any amount will help. Donations are deductible for U.S. income tax purposes even if you do not itemize deductions. Mail your donation to the:

If the response from the DX community is affirmative, the IDXF will close the remaining gap. If not, the IDXF funds will be used to carry on other ongoing plans.

The IDXF was established with a large donation by KP2A in 1978 to promote international goodwill and understanding. KP2A, John Ackley, President of Transidyne General Corporation in Ann Arbor, Michigan (a public stock company), is founder and President of IDXF. N2CW, Gary Medford, ATT, is Treasurer and Vice President. KB2XS, Rudy Lehnert, President of NASSAU DEL, Inc., is Vice President Operations.

WODX (VP2VI), Bob Dennison, formerly President of the American Radio Relay League, is Vice President, DX Committee. N200, Bob Schenck, New Jersey Bell, is Vice President, Public Relations. Stu Green, WA2MOE, Attorney, American Home Products Corporation, is the IDXF's General Counsel. The Board of Directors is KP2A plus W2EE, Mort Rogoff, President, Navigation Sciences, Inc., and WB2IEI, Rick VanVecten, President of TDA, Inc.

Dr. Dan Handelsman, M.D., is Heard Island project manager on behalf of IDXF. The IDXF will provide a QSL manager and print the expected 40,000+ QSL's.

MAY QST contains the complete text of FCC proposal 82-83, concerning 'phone band expansion for U.S. amateurs (page 51) and a League editorial on page 9.

League members wishing to express their opinions on the matter should write to the Plans and Programs Committee, c/o ARRL Headquarters.

Two points in the editorial bear repeating...the "foreign phone bands" have outlived their usefulness because split frequency work on phone is (unfortunately) no longer widespread. The League feels (and TDXB agrees) that it is time for this "private preserve" for non-U.S. stations to be scaled down.

The second critical point is that in most countries phone and CW band segments are merely "gentlemens' agreements," and the possibility always exists that some overseas amateurs, seeing their private phone band invaded by U.S. stations, might simply move their SSB operating down below 14.100 MHz.

We do not need another phone vs CW brouhaha!

FCC's "Plain Language Rules" proposal was scuttled by an outpouring of letters from hams. We think the League's proposal makes much more sense than Docket 82-83 and should be supported.

THIS WEEK marks five months that our ham friends in Poland have been off the air. We miss them. Now Argentina has silenced their radio amateurs, and on the Falklands even SWL receivers were confiscated. In China, it has taken twenty years to get a ham station on again, and everyone is saying "go slow." Everytime the Russians take over a country, good-bye radio. Why do you suppose S. Yemen is not allowing amateur radio? And what about Angola, Ethopia, Viet Nam, Campuchea, etc?

Amateur Radio is a weathervane...there are plenty of USSR stations on, and Cubans, too.

It is scary that Argentina's military rulers acted so swiftly to put LUs off the air.

Somebody should tell them that hams never, never talk about anything meaningful on the air. And hamming keeps us off the streets, too!
