ARRL BULLETIN NR 121 FROM ARRL HEADQUARTERS

The final plenary meeting of WARC 79 was completed on the evening of Monday, December 3, and Amateur Radio has fared extremely well. Because of the pressures on the spectrum, it would have been a victory to have maintained the status quo. But we have more than maintained the status quo. There are three new amateur bands, at 10, 18 and 24 MHz. In addition, there have been significant improvements in our UHF status. Preliminary details will be found in the January issue of QST, and the February issue of QST will carry the full story. Our success is because of excellent worldwide amateur preparation prior to the conference and because of the excellent participation at the conference by many, many people. Our deepest gratitude to all of you who gave us your support and encouragement from the beginning to the end AR

We are literally typing this as the press warms up. The above Official Bulletin from ARRL Headquarters pretty much says it all. Three new HF bands may be the most exciting thing to happen to amateur radio since its beginnings over fifty years ago. We started with harmonically-related bands on 80, 40, 20, and 10, so crystals would work on all four (ideally). 15 Meters was added later and that's the way the major HF bands have been structured for most of our amateur lifetimes. If we do indeed get three new bands, the implications are mind boggling. The first important factor in this editor's opinion will be a revitalization of operating for many of us. No longer will five band DXCC be enough; those of us who have it will now struggle for another 300 band-countries to make 7-Band DXCC. Can you imagine. And what about contests? In these sunspot-rich years it is already nigh impossible to decide what band to be on, with three or four of them open simultaneously; good grief. There will be less crowding, especially when the 'spots are down again...no longer will 20 Meters have to bear the brunt of long distance traffic for years at a time. The possibilities are endless.

YASME PRESS RELEASE ... "Effective 23 November 1979 there has been a reorganization of the YASME Foundation QSL handling personnel. Primary sort of all incoming mail and first response to each operation is being handled by W6BSY with assistance from WB6DOQ. Continuing response to all YASME Foundation DXpeditions, past and present, is being handled by WA6AKK. "The previous team was led by Ferne Hughes and WA6AHF, with assistance on continuing response by K6YK, K6PBT and WA6CPP. They have now concluded their association with the YASME Foundation, and we thank them for their many hours of time and effort."

EISH The following appeared in ZL2HE's DXing column in Break-In, the Official Journal of the New Zealand Association of Radio Transmitters, Inc...

"E18H-This station has been one of the biggest sources of QRM to DX for years, and has been silenced. The operator, an aging Patrick, has finally been tricked into being caught for his blatently stupid action on the bands. His consistent jamming, bugging, and illicit operation has resulted in him losing his E18H call. It all came about after Patrick bugged so many DX nets with his high power signals. If one had worked in or listened in on any DX net it would be found that sooner or later he would show up. He created chaos by placing a carrier on the net frequency; on many occasions it was associated with music, bells, chiming, or buzz saw noises which completely disrupted the operation. European stations could not work weak Pacific or other DX because of the bedlam. He certainly achieved his goal. On another operation his call would appear with E18H/A, GT, GJ, HBØ and many other areas. All of which cost DX: dollars, IRCs, and postage for no end result. His operation was also linked with many other bogus calls as well.

"His downfall came about on August 1, when P29JS and several European operators But their plan to the test. They gave advance notice about a special station which was to show up on the P29JS (Jim Smith) net. SM5BBC made arrangements at the European end with the EI Post Office officials to be ready. Tracking stations in South West England, CT2 and SM soon confirmed their suspicions.

"Patrick duly came on as they expected and the Post Office officials swooped in, catching him red handed. His license was cancelled, but they could not confiscate his station. If he were to operate again without a license the officials (cont'd)

could then take all his station away.

"The person largely responsible for the closing down of EI8H has been SM5BBC, who has brought diplomatic pressure to bear on the EI Post Office to do something about the mess being created by the action of EI8H. SM5BBC is to be commended for his action which has nearly made him bankrupt. Financial remuneration is recommended to ZLs; if you can spare a dollar or IRCs, I suggest you send it; it will give confidence to those who are prepared to fight for the clearing of our DX bands of unwarranted, selfish operators who mean to cause hardship to Amateur Radio."

50 MHZ DESK...We got a local 6 Meter reporter the other day, and his first report came in today. Now all we need is a midwest and west coast source. Anyhow, our man in East Hartford took time from working states number 45 and 46 on two meters to give the following: On Nov. 24, VEIASJ worked ZLIAUM and ZLIAVZ, after which KITOL got into New Zealand.
