PROPAGATION FORECAST: May 22, 23, 24, High Normal; May 25, Above Normal; May 26-28, High Normal; May 29-31, Above Normal; June 1, Above Normal. TNX N4XX.

OSCAR... This information is entirely from the May 16 issue of HR REPORT:

"The Phase III satellite is still scheduled for launch this coming Friday, May 23, from Korou, French Guiana. Launch window is 1130-1430Z Friday, though there could be a delay of up to a week if problems arise.

"Pre-launch information bulletins begin May 16, transmitted on 3850 nightly at 0200Z. Higher frequency bulletins begin Monday, on 28555 at 1800, 1900 and 2300Z;

21260 at 1815, 1910 and 2310Z, and 14260 at 1830, 1920 and 2320Z.

"Launch day real time coverage will be on 7290, 14260, 14290, 21390 and 28590. The 145.808 plus/minus doppler satellite beacon will fire up after separation, which will take place 15-18 minutes after launch, and be on the first half of each hour. However, Phase III won't be available for use until after days of thorough checkout."

The launch day real-time coverage should make for exciting listening!

MADEIRA... DL7FT/CT3 showed up on schedule last week and has been very active; he is talking on the air about the proposed Albania operation mentioned first a month or so ago.

RWANDA.., Eric Sjolund, SMØAGD came on from 9X5LE Saturday, May 17, operating mostly CW 25 KHz up from the band edges. No indication of length of stay. QSL SM3CXS.

W/LPF/DU2 intends a full-bore effort in the CQ WPX CW Contest this weekend; he will be on 80 Meters as well as the other bands.

TI 9PN operator is reportedly the Cocos Island "park ranger" and a long stay is expected. He frequents 14200-220 at 0100-0200 UTC.

TOGO'S 5V7GE, an elusive one, is most often found on 14260 at 0000; his mailing address is Garland Edmonds, B.P. 3078, Lome, Togo, West Africa.

PACIFIC STATIONS may often be found gathered with WB6LED at 14280/0530Z. This happens irregularly but several times a week, with T3, C21, W6ENK/KH4, etc.

ETSPG CARDS are showing up again. It is imperative when you work the station to get the operator's name and his individual post box number, as each operator handles his own QSL chores.

"The Jones Act of 1917 gives Puerto Rico unequivocal control of its offshore territories, including Desecheo and hundreds of other rocks and cays. The ARRL DXAC apparently was in error when they ruled that Puerto Rico is foreign to Desecheo and is separated from the 'foreign Virgin Island!' DXCC Rule 3 was applied incorrectly. How can two islands that fly the same flag (KP4 and KV4) be foreign to one another? DXAC says in the case of Desecheo thay are. The same principle applied fairly would create virtually hundreds of new countries.

"DXAC with pressure from ARRL bent the rules and the result they are stuck with has glaring inconsistencies they cannot explain. Contrary to DXAC, Desecheo is not foreign land to KP4, nor is KP4 foreign land to the Virgin Islands. They may be different DXCC countries but that is not what Rule 3 requires. What makes things worse is the landlords of Desecheo (the U.S. Fish and Wildlife Bureau) do not want to issue any more permits for amateurs to go to Desecheo. Unless, of course, KP4AM and the NCDXA figure out a new plan. YASME was turned down and several other individuals have also been refused. A deletion is in order. Let's stop creating phony countries just to please special interest and pressure groups."

BOX 74556 Fairbanks, Alaska 99707 SAUDI ARABIA We received a letter recently about the activity from HZ1AB, and wanted to print it after "Death of a Princess" aired on Public Television. Ironically, the letter came from Houston, which was one of the cities where the local TV PBS affiliate was pressured into NOT running the show; the other places which did not run it were Los Angeles, North Carolina and parts of Alabama.

In case you missed the publicity surrounding the show, which was in episode in the "World" series which we plugged in this paper a couple of months ago, the Saudi government asked the US State Department to prevent the show's airing in the US. Most of Western Europe had already seen "Death of a Princess." As it turned out, the two-hour "docu-drama" was good soap opera and that was about it. Surely most viewers realized that one unfortunate affair in the Royal Family does not a country make. Can you imagine the US keeping "All in the Family" off the air overseas so others won't think we are all Archie Bunkers? Anyhow, here's the letter:

"HZIAB is licensed to the U.S. Military Training Mission at Dhahran, Saudi Arabia. The station was first licensed after WW-II when the U.S. constructed what is now Dhahran International Airport as then Dhahran Air Base. The installation now serves Saudi Arabia both as an international airport and as one of the military air bases.

"HZIAB is the only station in Saudi Arabia where US amateurs may operate legally. And, only US citizens may legally operate the station—a situation that upsets some of the other nationalities working nearby. The station license has been effect continuously since first issued, and there is no indication that it will not continue in effect. However, no licenses are currently issued to non-Saudi citizens—NONE! Contrary to what certain individualists have done in operating illegally from the country, there is no expatriate operation from HZ that is legal except from HZIAB.

"For a variety of reasons, including mutually cooperative factors, a limited number of amateurs employed by the oil company are permitted to operate the station as visiting ops (we assume by "oil company" he means ARAMCO-Ed.). I have operated extensively from HZIAB, and was instrumental in bringing a degree of order out of the chaos of the QSLing situation.

"In 1977, K8PYD was selected as the QSL manager for the station. He has continued in that role, and has copies of all current logs, i.e., from about 1976 forward, except for a few pages lifted by one or more of the visiting ops. These characters are either gone, or not permitted to operate now. Leo also has a record of all periods for which logs are available at the station, many of which have disappeared over the intervening years. Thus, Leo is able to either QSL for contacts or direct old inquiries to the station. The latter usually go over there with (me) so that I can personally search the logs.

"From time to time, a visiting operator will decide that he wants to handle QSLs differently. This is not approved by the USMTM, and cards issued in that manner can probably be challenged for DXCC credit. This is not to say that certain cards issued by a variety of other managers are not legal—just that they may be. A certainty is that a card issued by K8PYD is completely legal and acceptable for DXCC credit.
